

DRINKING WATER TESTING CLINIC

CULPEPER, RAPPAHANNOCK, FAUQUIER COUNTIES



- Does your water come from a well, spring or cistern?
- Do you want to learn more about the quality of your water?

How it works:

1. At a brief informational meeting, pick up a sample kit and get instructions to collect your household water sample.
2. Collect a sample from your tap at home and complete a short questionnaire.
3. Drop off sample at a designated location and time.
4. About 4 weeks later, come back to get your confidential test results, an explanation of what the numbers mean, and information on how to handle any problems that are present
